Models Affected: Specific Freightliner Custom Chassis Corporation B2 and S2 bus chassis manufactured February 6, 2013, through May 20, 2013, with certain Cummins EPA 2013 engines.

### **General Information**

The vehicles mentioned above may be equipped with an improperly functioning on-board emission-related diagnostic system that violates (California or California and Federal or Canadian) standards and regulations.

The U.S. Environmental Protection Agency has determined the vehicles mentioned above may be emitting pollutants in excess of the Federal emission standards (and/or California standards) as defined in Title 40 of the Code of Federal Regulations. Environment Canada has determined the vehicles mentioned above may be emitting pollutants in excess of the Canadian Environmental Protection Act, 1999. These emission standards were established to protect the public health or welfare from air pollution. In order to ensure customers' full protection under the emission warranty made applicable to these vehicles by Federal law, and customers' rights to participate in future Recalls, it is recommended that vehicles be serviced as soon as possible. Failure to do so could legally be determined to be a lack of proper maintenance of a vehicle. ## **Work Instructions**

### **Emissions Recall: Malfunction Indicator Lamps**

Models Affected: Specific Freightliner Custom Chassis Corporation B2 and S2 bus chassis manufactured February 6, 2013, through May 20, 2013, with certain Cummins EPA 2013 engines.

### **Bulkhead Module Parameter Change**

IMPORTANT: This procedure must be completed using the ServiceLink<sup>®</sup> diagnostic program. Any vehicle registered in the State of California requires an *Emissions Campaign – Proof of Correction* certificate showing this Recall has been completed. A certificate form is included at the end of this bulletin for this purpose.

- 1. Check the base label (Form WAR259) for a completion sticker for FL646 (Form WAR260) indicating this work has been done. The base label is usually located over the drivers window. If a sticker is present, no work is needed. If there is no sticker, proceed with the next step.
- 2. Park the vehicle on a level surface, shut down the engine, and set the parking brake. Chock the tires.




Fig. 1, Diagnostic Connector (location will vary)

- 3. Connect the laptop being used to a power adapter, then connect the laptop connector to the diagnostic connector. See **Fig. 1**.
- 4. Turn the ignition switch to the "ON" position, or connect a battery charger to the vehicle.
- 5. In ServiceLink, click "Bulkhead Module."
- 6. Next, click "Features."
- 7. Look for parameter 26-02116-001 in the Features list. If it is there, click "Refresh Features List," and the parameters will be programmed into the bulkhead module (BHM).
  - If parameter 26-02116-001 is not shown in the Features list, type the parameter in the "Enter New Reference Parameter" box. Click "Add to List," then click "Apply Changes." ServiceLink will update the BHM with the new parameter.
- 8. A message screen will appear showing "vehicle update successful." Click "OK."

- 9. Remove the laptop connector from the diagnostic connector.
- 10. If the vehicle is registered in the State of California, complete a copy of the *Emissions Campaign Proof of Correction* certificate included at the end of this bulletin and provide it to the customer.
  - If the vehicle is not registered in the State of California, skip this step and go to the next step.
- 11. Clean a spot on the base label (Form WAR259), write the Recall number FL646 on a completion sticker (Form WAR260), and attach it to the base label.
